# 2015-2016 Faculty Salaries of James Madison University's Academic Council Peer Group Adjusted for Cost-of-Living 

Faculty Senate, Budget and Compensation Committee *

February 1, 2018

A comparison of average faculty salaries is made between JMU and its 2015 Academic Council Peer Group, based on the academic ranks of professor, associate, and assistant. This peer group consists of 14 universities, including JMU. The average salaries are taken from The Chronicle of Higher Education, https://data.chronicle.com/category/sector/1/facultysalaries/, but unfortunately are based on academic year 2015-2016 rather than 2016-2017 or 2017-2018, since these latter salaries are unavailable. The population sizes of the faculty, based on university and academic rank, are listed in Table 1, and the average salaries are listed in Table 2. All salaries listed herein were collected from the internet on December 18, 2017.

The data are analyzed both with and without a cost-of-living adjustment, based on each metro area for the university. The online cost-of-living calculator used herein is from http://www.bestplaces.net also on December 18, 2017. Other competing calculators are also available online.

Without taking cost-of-living into account, JMU has rankings of \#11, 9, and 8 (from the top) among the 14 universities for the academic ranks of professor, associate, and assistant,

[^0]respectively, as shown in Table 2. These rankings correspond to percentiles of $25 \%, 39 \%$ and $46 \%$ (from the bottom). However, JMU has the 8th highest cost-of-living among the 14 universities, according to Table 3. JMU's rankings from the previous year 2014-2015 were somewhat worse, \#13, 13, and 9 (from the top), corresponding to percentiles of $11 \%$, $11 \%$, and $39 \%$ (from the bottom), and JMU had the 9th highest cost-of-living. Dividing the salaries from Table 2 by the cost-of-living from Table 3 and multiplying by JMU's cost-ofliving produce Table 4, which shows the average faculty salaries adjusted for cost-of-living in terms of JMU dollars. Therefore, taking cost-of-living into account, JMU has rankings of $\# 9,9$, and 7 (from the top) among the 14 universities for the academic ranks of professor, associate, and assistant, respectively, as shown in Table 4. These rankings, adjusted for cost-of-living, correspond to percentiles of $39 \%, 39 \%$ and $54 \%$ (from the bottom). JMU's rankings from the previous year 2014-2015 were only slightly worse, \#9, 10, and 7 (from the top), corresponding to percentiles of $39 \%, 32 \%$, and $54 \%$ (from the bottom).

Aggregating the three academic ranks (professor, associate, and assistant), based on weighting the salaries from Tables 2 and 4 by the population sizes from Table 1, produces Table 5. Without taking cost-of-living into account, JMU has the ranking of \#11 (from the top) among the 14 universities, and is hence in the 25th percentile (from the bottom), based on Table 5. JMU's ranking from the previous year 2014-2015 was worse, \#13 (from the top) and 11th percentile (from the bottom). Furthermore, taking cost-of-living into account, JMU has the ranking of \#9 (from the top) among the 14 universities, and is hence in the 39th percentile (from the bottom), based on Table 5. JMU's ranking from the previous year 2014-2015 remains unchanged. Some universities have a high or low proportion of assistant professors relative to the peer group (noting Table 1), so only limited credibility should be given to Table 5.

Excluding the cost-of-living adjustment, the average salaries for professors, associate professors, assistant professors, and all faculty are graphed in Figures 1a, 1b, 1c, and 1d, respectively. However, including the cost-of-living adjustment, the corresponding average salaries are graphed in Figures 2a, 2b, 2c, and 2d.

Moreover, regarding cost-of-living, only a limited amount of consideration should be taken into account. For example, Fredericksburg (home of University of Mary Washington,
although not a member of JMU's 2015 Academic Council Peer Group) has a higher cost-of-living than Harrisonburg. However, some hefty expenses are pretty much identical for both JMU and UMW employees. Examples include expenses related to sending our own children to college, going on vacation to Virginia Beach, and retiring in Florida.

Finally, a huge caution should be noted when interpreting Tables 2, 4, and 5. The data provided by The Chronicle of Higher Education do not take into account academic programs, noting that universities with (for example) a relatively high proportion of Business faculty will tend to have a high overall average salary. However, if we momentarily ignore this huge caution, then the data herein hint that JMU tends to offer competitive salaries for assistant professors, but not for professors and associate professors - Suggesting that JMU is competitive in the market for new hires, but JMU is not adequately addressing compressed and inverted salaries among faculty of higher ranks.

The endowments of the universities are listed in Table 6 and graphed in Figure 3, both excluding and including the adjustment for cost-of-living in terms of JMU dollars. Without taking cost-of-living into account, JMU has the ranking of \#10 (from the top) among the 14 universities, and is hence in the 32 nd percentile (from the bottom), based on Table 6. Furthermore, taking cost-of-living into account, JMU has the ranking of \#9 (from the top) among the 14 universities, and is hence in the 39th percentile (from the bottom), based on Table 6.

These endowments for twelve of these universities (excluding College of Charleston and Towson University) are available in a 2017 report entitled "U.S. and Canadian Institutions Listed by Fiscal Year (FY) 2016 Endowment Market Value and Change in Endowment Market Value from FY2015 to FY2016" from the National Association of College and University Business Officers and Commonfund Institute.
